Thank you for the information you have submitted following the meeting held over 6 months ago. As advised at the meeting, Officers were of the opinion that because of the time period that had lapsed since the initial submission of the planning application, together with the changes in policies and the amendments to the proposal, the submission of a new planning application would be required.

The work required by yourselves to put the documents together took over 6 months and almost every document on the application appears to have been amended/updated. This will therefore require the whole application process to be followed again from the start, with the application being advertised and consultations carried out. All the reports and documents together with the responses to the consultation will then need to be analysed and assessed and reports produced. This is a whole new application process and not just a minor amendment to a scheme that was recently consulted on. It is acknowledged that the original application was not determined and has not been withdrawn. You had a right to lodge an appeal against non-determination but elected not to follow this process within the statutory time period. The Council did not request an extension of time to determine the application, although offered by yourselves this was not accepted. Your right to appeal therefore appears to have lapsed.

I can therefore only advise that a new application be submitted if you wish the Council to formally consult on and determine the proposal.
