c.	information provided in or with the application is false or misleading.	

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations prescribe the fees and other requirements in relation to the registration of non-commercial societies for the promotion of small society lotteries under the Gambling Act 2005 ("the Act").

Regulation 3 and the Schedule to these Regulations set the application fee and prescribe the form in which an application for registration must be made.

Paragraph 44(a) of Schedule 11 to the Act requires local authorities to enter the applicant, together with any prescribed information, in a register. Regulation 4 requires local authorities to record in the register the date on which that entry is made.

Regulation 5 prescribes the annual fee payable by registered societies to local authorities and the period within which it should be paid.
